

GENERAL INFORMATION/REQUIREMENTS FOR ALL REGISTRATIONS:

Documentation of pedigree/background on PtHA registration certificate will be determined by adherence to the registration rules outlined herein.

*Send 3 **current** color photos of animal, covering an approximate area of 3" x 3". (Photos with image of animal exceeding 3" x 3" are unacceptable.) (1) **Full** frontal view (i.e. head-on); and (2) **Full** profile/side views of left and right sides. All photos should include all parts of animal available in that view (i.e. ears to hooves or nose to tail) and be unobstructed by any other animals, riders, or fences or foliage in the foreground. Additional closeup photos should be submitted to show color not evident in the usual three photos mentioned herein (i.e. belly white, white under jaw, etc.). Label back of each photo with animal's first name choice and owner's name.

*Copies of outcross registration papers submitted in lieu of completed Breeder's Certificate or for sire or dam must verify and exhibit ownership as submitted on this registration application, or include a completed copy of the pertinent outcross registry transfer report.

*Send **copy** of sire's or dam's registration papers verifying ownership and pedigree **IF** they are not registered nor listed with PtHA **OR** if you are NOT sending a copy of THIS animal's outcross registration certificate. **DO NOT SEND ORIGINAL REGISTRATION CERTIFICATES FROM OTHER REGISTRIES.**

*Fees paid to PtHA are not refundable, including registration fees, if the animal is eligible for any of our registry classifications. A \$15.00 processing fee will be retained by PtHA on all canceled or uncompleted work. PtHA reserves the right to classify and register based on the information and photos received with the initial application.

*Registration applications must be completed in entirety and submitted with all fees, photos, and necessary documentation as outlined herein. Incomplete applications will be subject to return or lengthy delays in processing and possible additional fee assessments.

***Allow at least six weeks for processing work submitted to the office. For applications submitted through a Sector Director, allow at least 90 days from the date of issue.** Registrations needed in a shorter time frame should be marked with and accompanied by the appropriate rush fees.

FOR COLOR OR BREEDING STOCK REGISTRATION OF HORSE STALLIONS/COLTS OR HORSE MARES/FILLIES, PLEASE REFER TO ITEMS A) THROUGH F) BELOW AND NOTE DEFINITION OF HARDSHIP. HARDSHIP FEES ARE NOT APPLICABLE TO GELDING REGISTRATIONS.

A) BOTH sire and dam must be registered with PtHA or an approved outcross breed registry AND:

B) Any sire registered with an approved outcross breed must also be listed with PtHA for his 1983 or after foals to be eligible for PtHA registration. **NOTE: EFFECTIVE 01/01/90, NO PINTO-MARKED APPROVED OUTCROSS REGISTERED STALLIONS, INCLUDING APHA REGISTERED STALLIONS (COLOR OR BREEDING STOCK) WILL BE ACCEPTED FOR LISTING WITH PtHA. SUCH STALLIONS WILL HAVE TO BE REGISTERED WITH PtHA.** Stallion Breeding Reports are required and must be submitted by stallion owners for all stallions registered OR listed with PtHA.

C) 1987 and after foals produced out of Pinto-marked mares registered with another recognized outcross registry (including APHA Breeding Stock mares) will be assessed an additional Mare Penalty (i.e. Hardship) fee if said mare is not also registered with PtHA.

D) STALLIONS WITH UNKNOWN, UNDOCUMENTED, OR UNREGISTERED (APPROVED OUTCROSS REGISTRY) PARENTAGE OR BACKGROUND ARE NOT ELIGIBLE FOR PtHA REGISTRATION.

E) HARDSHIP INCLUDES: (NOT APPLICABLE TO GELDINGS)

- 1. Horses not having both parents registered with PtHA or an approved outcross breed.
- 2. Failure to submit or lack of required/requested documentation (i.e. Stallion Listing, Stallion Breeding Report, Breeder's Certificate, or other requirements as outlined herein).

F) GRANDFATHER CLAUSE: Available to horses whose sires and dams are both registered with PtHA or an approved outcross breed and who have two or more generations of registered AND documented APHA-colored, PtHA-colored, or other approved outcross registered Pinto-colored horses in the immediate background/pedigree. Two generations may be defined as sire/grandsire, sire/granddam, dam/grandsire, dam/granddam, or sire/dam. The GRANDFATHER CLAUSE form of registration waives the normal necessity of Stallion Listing, Stallion Breeding Report, Mare Penalty, etc. as outlined above, and is only available to current members or those applying for membership.

WEANLINGS: ALL SEXES & DIVISIONS

Within six (6) months after date of foaling and within foaling year: \$20.00
After six (6) months from foaling date, but on or before Dec. 31 of foaling year: \$35.00

COLOR DIVISION HORSE MARES OR STALLIONS

Received during yearling year: \$65.00
Received during horse's two year old or older year: \$100.00

BREEDING STOCK, GELDINGS, OR SPAYED MARES

Received during their yearling year or thereafter: \$35.00

GRANDFATHER CLAUSE (For qualifying horse stallion or mare, any age): \$65.00
(See definition at left. Available ONLY to current and/or applying members.)

STALLION LISTING FEE (Members or Non-Members): \$25.00
(Stallion Listing requires different application form. Contact PtHA office.)

HARDSHIP FEE (IN ADDITION TO REGISTRATION FEES): \$175.00
(See definition at left. Not applicable to gelding registrations.)

RUSH PROCESSING

For any work desired prior to the minimum required six (6) weeks processing time, special rush processing is available as outlined herein. Rush time is calculated from the date ALL documentation, photos, and fees are received by PtHA until date the certificate is mailed from the PtHA office. Rush registrations and ALL ASSOCIATED fees must be paid via Cashier's Check, Money Order, Visa, Mastercard, or American Express and envelope and application clearly marked "RUSH".

7 Working Day Rush: + \$20.00
72 Working Hour Rush: + \$35.00
Return via Express Mail: + \$20.00

IMPORTANT NOTICE: All registrations are subject to further investigation and review at the PtHA Business Office. Color qualifications will be determined by and must be evidenced by photos submitted to the office. The PtHA Business Office will make final determinations on eligibility. NO animals with Appaloosa, Mule, or Draft breeding or characteristics are eligible for PtHA registration. All registrations subject to review and cancellation at any time. Conditional Sector Director registrations are temporary and tentative until reviewed and finalized by the PtHA Business Office, and are subject to further research, requirements, and/or cancellation by the PtHA Office.
